ARTICLES OF INCORPORATION

The undersigned incorporator for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the Corporation is **WEB SOURCE HOLDINGS OF FLORIDA, INC.** (the "Corporation").
- SECOND:** The principal office address and mailing address of the Corporation is 5030 Champion Blvd., G-6 #192, Boca Raton, FL 33496.
- THIRD:** The Corporation is authorized to issue 1,000 shares of common stock, par value \$.001 per share.


