Nature of Business**

The general nature of the business to be transacted by this Corporation shall be:

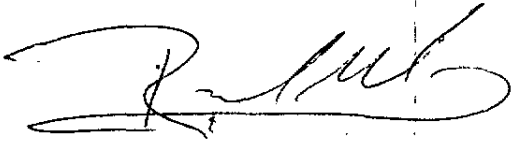
ARTICLE TEN

Amendment

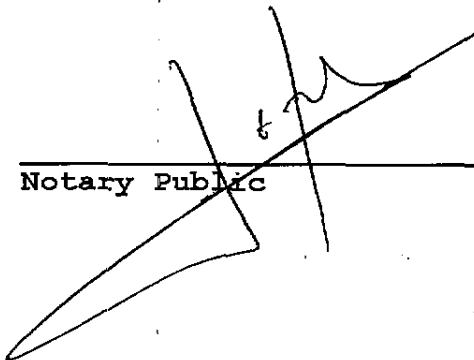
