ARTICLES OF INCORPORATION

OF

ARTICLE I NAME

The name of the Corporation is: RICHARD R. TUFANO, JR. RESCREENS, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE
