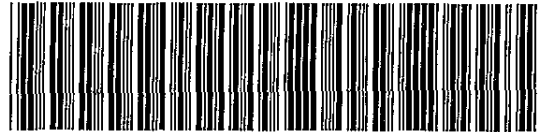

ARTICLES OF INCORPORATION  
OF

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE  
NAME

The name of the corporation is CHOCK AND BLOCK MARINE, INC.

ARTICLE TWO  
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE  
PURPOSE

The purpose for which the corporation is organized is to provide boat transport services for profit.

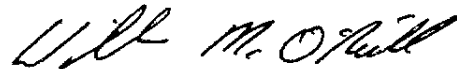
ARTICLE ELEVEN

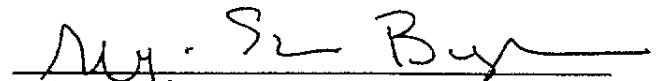

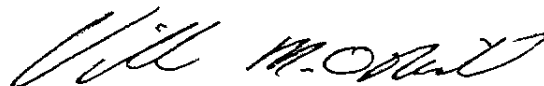
