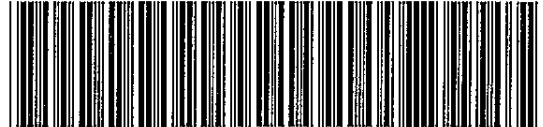

**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation shall be:

This Corporation shall have perpetual existence commencing
on 12/01/03.

ARTICLE IX - AMENDMENT

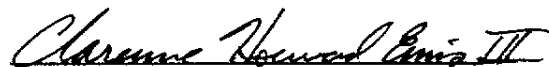
