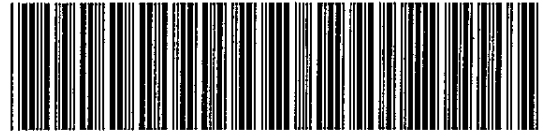

**ARTICLE I - NAME**

The name of this corporation is **DELTONA SOD SERVICES, INC.**, located at 1161 S. Brickel Drive, Deltona, Florida 32725.

**ARTICLE II - DURATION**

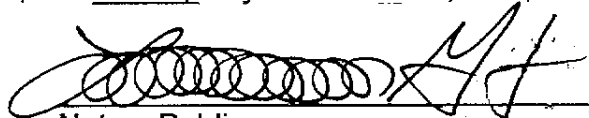

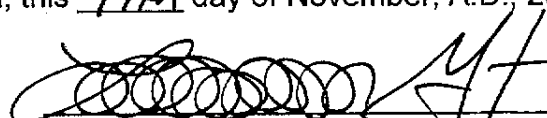
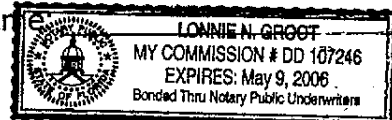
