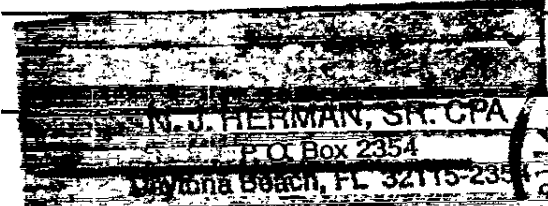

ARTICLES OF INCORPORATION

OF

The undersigned subscriber, being of natural person,
competent to contract for the purpose of forming a corporation

Articles of Incorporation for such corporation:

ARTICLE I
