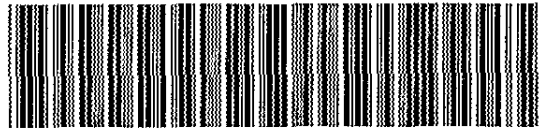

ARTICLE I. CORPORATION NAME

The name of the corporation is:

The general nature of the business to be transacted by this Corporation is to engage any and all business as permitted under the laws of the State of Florida.

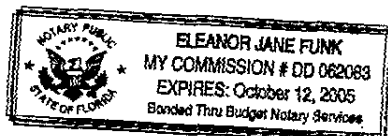




