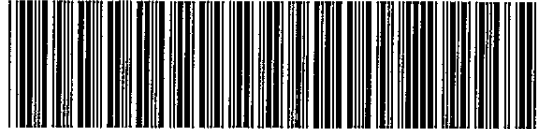

In compliance with Chapter 607 and/or Chapter 621, Florida Statutes

ARTICLE I

The name of the corporation shall be Cytryn & Santana Advertising, Inc.

ARTICLE II

The principal place of business and mailing address shall be 8100 North University Drive, Suite 202, Tamarac, Florida 33321.

ARTICLE III

The purpose for which the corporation is organized is to conduct activities relating to advertisement for and on behalf of Law Offices of Cytryn & Santana, P.A.

ARTICLE IV

The total number of shares that the corporation is authorized to issue is 100 shares. The shares shall have a par value of \$75.00 each.


