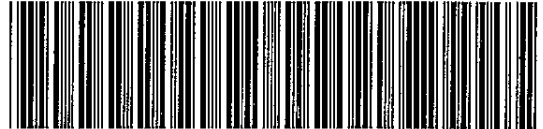

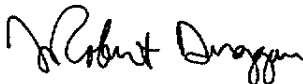

ARTICLE I. NAME

NAME: The name of this corporation is STAN DUDLEY, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the 25th day of  
November, 2003.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of operating a plumbing and electrical company and transacting any and all other lawful business in the State of Florida and the United States of America.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of (\$1.00) par value common stock.

ARTICLE V. PREEMPTIVE RIGHTS

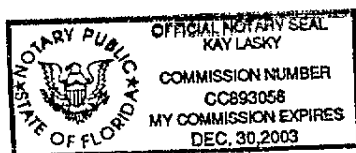
