We, the undersigned subscribers, all being of full age, have associated ourselves together for the purpose of forming a corporation for-profit, under the provisions of all applicable <u>State of Florida Statutes</u>. We hereby accept all the rights, privileges, benefits and obligations conferred and imposed by said law, and we do hereby, subscribe, acknowledge and file these Articles of Incorporation.

#### **ARTICLE I**

NAME: FAULK LAND CLEARING, INC

### **ARTICLE II**

Purpose: Clearing land/site, Demolishing structures, All handyman activities

### **ARTICLE III**

Term Of Existence: The term of existence of this corporation is perpetual.

### **ARTICLE IV**
