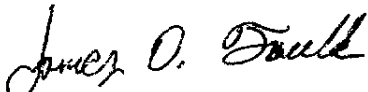

# ARTICLES OF INCORPORATION

We, the undersigned subscribers, all being of full age, have associated ourselves together for the purpose of forming a corporation for-profit, under the provisions of all applicable State of Florida Statutes. We hereby accept all the rights, privileges, benefits and obligations conferred and imposed by said law, and we do hereby, subscribe, acknowledge and file these Articles of Incorporation.

## ARTICLE I

**NAME: FAULK LAND CLEARING, INC**

## ARTICLE II

**Purpose:** Clearing land/site, Demolishing structures, All handyman activities

## ARTICLE III

**Term Of Existence:** The term of existence of this corporation is perpetual.

## ARTICLE IV

**Officers and Management:** The officers of this for-profit corporation shall be a President, Secretary, Treasurer, Financial Secretary. Management shall be vested in a board of directors; consisting of at least three (3) and no more than twenty five (25).

## **ARTICLE V**

## **ARTICLE VI**

**By-Laws:** The By-Laws of the corporation shall be made, altered or rescinded by a majority vote of the board of directors; provided that notice thereof, which shall include the text of the By-Laws change, has been furnished in writing to each member of the board at least ten (10) days prior to the meeting at which such By-Laws alteration is to be voted upon. Directors shall be elected or appointed in accordance with the By-Laws.

The Articles of incorporation of this corporation shall be amended or additional provisions adopted by a two-thirds(2/3) vote of the members of the board of directors present. Provided that notice thereof, which shall include the text of the Articles of Incorporation change is to be voted upon, followed by the compliance with the Florida Statutes regarding amendments to Articles of Incorporation of corporations Not-For-Profit.

## **ARTICLE VII**

**Capital Stock:** The maximum number of shares of stock that this corporation is authorized to issue is one hundred (100) shares of common stock, having a par value of one dollar (10.00) per share, all of which shall have voting rights. This being a private/ closed corporation with the following stipulations.

1. James Owen Faulk will own fifty (50%) percent of corporation
2. Owen Faulk will own forty (40%) percent of corporation
3. April Washington will own ten (10%) percent of corporation

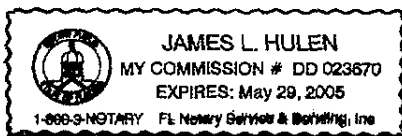
