#### ARTICLE I

#### NAME

The name of the corporation is Bill's Bobcat & Landscaping, Inc. and its mailing address is 4281 68th Avenue North, Pinellas Park, Florida 33781.

#### **ARTICLE II**

#### **DURATION**

This corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of Florida.

#### **ARTICLE III**
