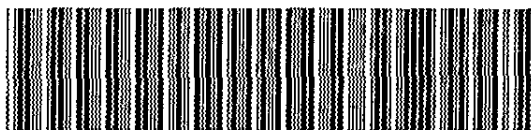



Name

The name of the corporation shall be ABC MOTORCYCLE SAFETY, INC.

ARTICLE II

Initial Board of Directors



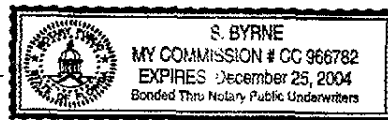
