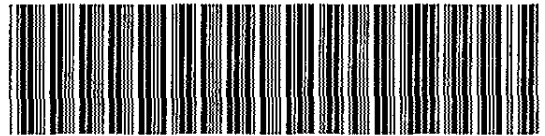

**ARTICLE I - NAME**

The name of this corporation shall be, JIM REYNOLDS' QUALITY DRYWALL, INC., and the address of the principal office of the corporation is 807 Narcissus Avenue, Holly Hill, FL 32117.

**ARTICLE II - EFFECTIVE DATE AND DURATION**

The term of existence of this corporation shall be perpetual after the effective date of December 5, 2003.

**ARTICLE IX - AMENDMENT**

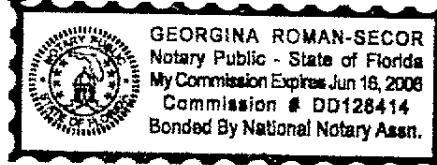

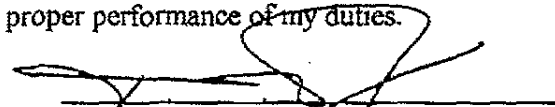
