ARTICLE I - NAME

ARTICLE VIII - BY-LAWS

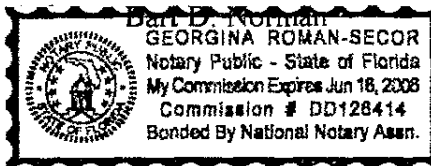
The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors.






