ARTICLE I - NAME

The name of the corporation is DAVID S. VACHON, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSES
