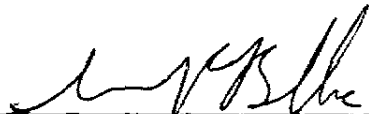

ARTICLES OF INCORPORATION

OF

SAM BELL ENTERPRISES, INC.

A Florida Corporation

ARTICLE I

NAME

The name of the corporation is Sam Bell Enterprises, Inc.
