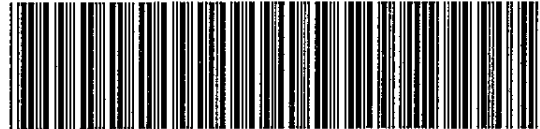

**ARTICLE I**

The name of this corporation is: **GEOFFREY ATWATER PAINTING, INC.,**

**ARTICLE II**

The term of existence of the corporation is perpetual.

**ARTICLE III**

The purpose of this corporation is to provide commercial and residential painting services and any and all other lawful business.

**ARTICLE IV - CAPITAL STOCK**
