**ARTICLE I**

The name of this corporation is: **T & M COMMUNICATIONS, INC.,**

**ARTICLE II**

The term of existence of the corporation is perpetual.

**ARTICLE III**

The purpose of this corporation is to install and provide communications infrastructure for residential and commercial communications services.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.


