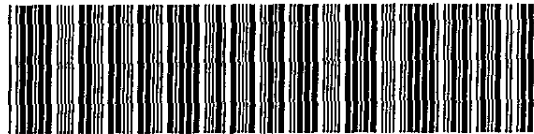

Shareholder Approval


The number of votes cast by the shareholders for dissolution was sufficient for approval.
