

ARTICLES OF INCORPORATION

OF



JOEL'S GIFTS, INC.

The undersigned, acting as incorporator of Joel's Gifts, Inc. under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is JOEL'S GIFTS, INC. ("Corporation").

ARTICLE II - COMMENCEMENT OF EXISTENCE

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

The Corporation will have one (1) director initially. The number of directors may be increased or diminished from time to time, as provided in the Bylaws. The Corporation will reimburse each person for all costs, legal and other expenses reasonably incurred by him in connection with any claim or liability as to which it will be adjudged that such Officer or Director is liable to the extent permitted by law.
