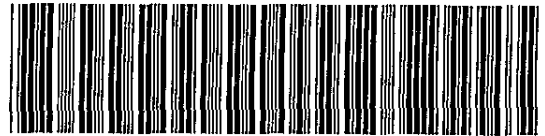

ARTICLES I - NAME

SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

The name of the corporation shall be Adam M Harper Building, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence and shall commence upon filing hereof.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of operating as a building contractor for commercial & residential dwellings and for all other purposes as allowed under County, State and Federal laws.

ARTICLE IV - CAPITAL STOCK

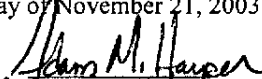
ARTICLE IX - OFFICERS

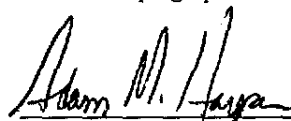
