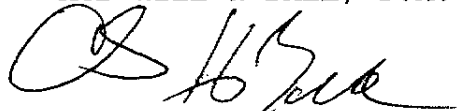

ARTICLE X AMENDMENT

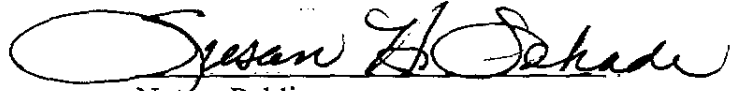

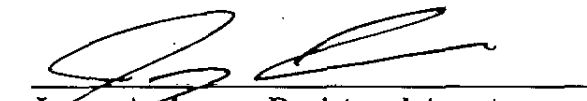
