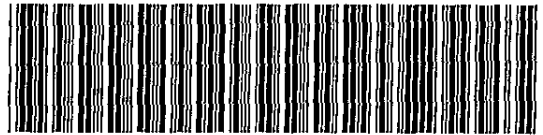

Articles of Incorporation of

Sal Valentino, Jr., Inc.

The undersigned, for the purpose of forming a Corporation under Chapter 607, the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME: The name of the Corporation is: SAL VALENTINO, JR., INC.

ARTICLE II: DURATION: The duration of the Corporation is perpetual.

ARTICLE III: ADDRESS: The street address of the initial registered office of the Corporation: 1492 Estuary Drive, Crystal River, FL 34429; the mailing address: 1492 Estuary Drive, Crystal River, FL 34429. The name of its initial registered agent is Sal Valentino, Jr., at 1492 Estuary Drive, Crystal River, FL 34429.

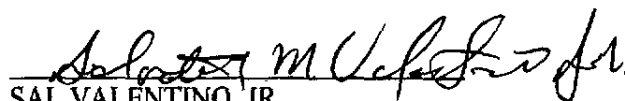
