ARTICLES OF INCORPORATION  
OF  
DAVEY PAINTING CORP.

The undersigned, for the purpose of forming a corporation in compliance with Chapter 607 and/or Chapter 621, F.S., does hereby adopt the following Articles of Incorporation:

Article 1. Name and Address. The name of the Corporation is Davey Painting Corp. The principal place of business and mailing address is 308 Sandhill Street, Marco Island, FL 34145.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation is organized are as follows:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purpose of the Corporation or necessary or desirable in order to accomplish them.

Article 4. Shares. The aggregate number of shares which the Corporation is authorized to issue is 100 shares of common stock. Such shares shall be of a single class and shall have no par value.

Article 5. Initial Registered Office and Agent. The street address of the initial Registered Office of the Corporation



is 247 N. Collier Blvd., Suite 201, Marco Island, FL 34145, and the name of the initial Registered Agent at that address is Daniel L. Jerry.

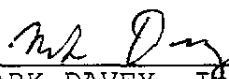
Article 6. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is one. The number of Directors may be increased or decreased from time to time in accordance with the By-Laws but shall never be less than one. Article 7. Incorporator. The name and address of the Incorporator is Mark Davey 308 Sandhill Street, Marco Island, FL 34145.

Article 8. Amendment. The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.

Article 9. Indemnification. The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

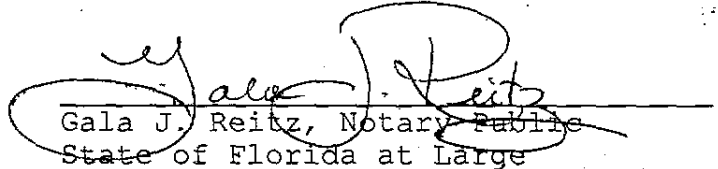

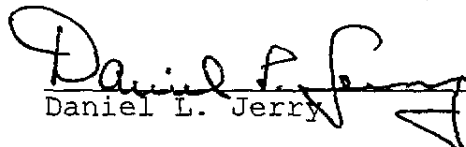
