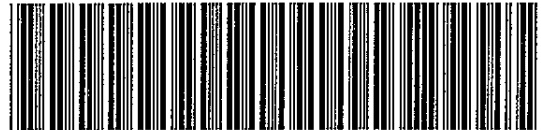

OF




