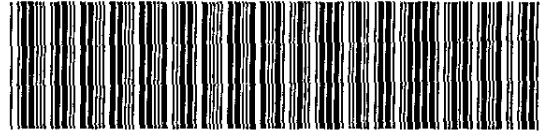



ARTICLE I - NAME

The name of this Corporation is ALEX TAVO, INC.

ARTICLE II - PRINCIPAL OFFICE AND
MAILING ADDRESS OF CORPORATION

ARTICLE III - DURATION

The Corporation shall have a perpetual existence.
