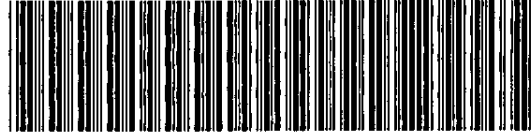

ARTICLES OF DISSOLUTION OF

MARATHON RESORT MANAGEMENT, INC., a Florida corporation

Pursuant to the provisions of the Florida Corporation Act (the "Act"), Marathon Resort Management, Inc. ("Company") does hereby adopt the following Articles of Dissolution:

1. The dissolution of the Company is authorized under the Act, Section 607.1403, Florida Statutes.

2. The dissolution of the Company is in compliance with the Act.

3. The Company consists of its Shareholders, all of whom are entitled to vote on a resolution to dissolve the corporate entity.
