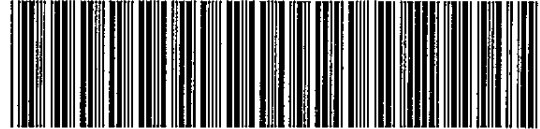



The name of the corporation is David Lee Budner, Inc.
