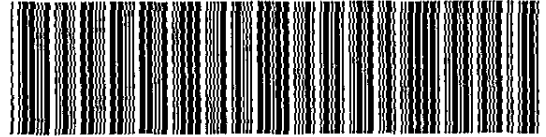

The undersigned hereby forms a Corporation under the laws of the State of Florida, and under the following Charter of Articles of Incorporation:

ARTICLE I

The name of this corporation shall be **BLUE LINE MARKETING, INC.**

ARTICLE II

The principal office and mailing address of the Corporation is 8130 Glades Road, #385, Boca Raton, FL 33434.

ARTICLE III

The general nature of the business to be transacted by this Corporation shall be to engage in providing business consulting services.

To invest the funds of the Corporation in real estate, mortgages, stocks, bonds, or any other type of investments, and to own real and personal property necessary for accomplishing the business purposes.

To do everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the Corporation, and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful activity necessary or incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes or objects of the Corporation.
