**ARTICLES OF INCORPORATION
OF
LAXMI PROSPERITY GEMS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be Laxmi Prosperity Gems, Inc.

ARTICLE II. PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be 11101 Roseland Road, Sebastian, Florida 32958. Its business shall be carried on in the State of Florida, in the United States of America, and elsewhere, as may be authorized by its Board of Directors or Stockholders.

ARTICLE III. PURPOSE

The general nature of the business to be transacted by the corporation shall include the provision of legal services as allowed by the Laws of the State of Florida and the licensing of the legal professionals acting hereunder.

The number of shares of stock that this corporation is authorized to have outstanding at any one time is one-thousand (1000) shares of (\$1.00) One Dollar par value.

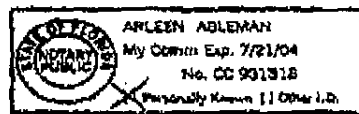
