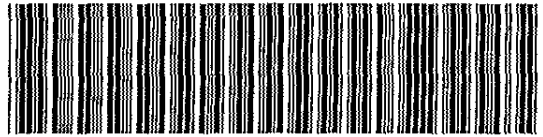

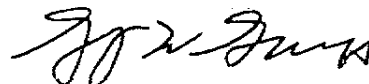

**ARTICLES OF INCORPORATION
OF
BRIAN F. SCHMIDT, INCORPORATED**

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be BRIAN F. SCHMIDT, INCORPORATED.

ARTICLE II - PRINCIPAL OFFICE

The principal office and mailing address for the corporation is at 1935 Lazy Lane, Cocoa, FL 32926.

ARTICLE III - TERM OF EXISTENCE

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.

ARTICLE IV - PURPOSES

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE V - CAPITAL STOCK

The corporation is authorized to issue and have outstanding One Hundred (100) shares of common stock having a par value of One Dollar (\$1.00) per share.
