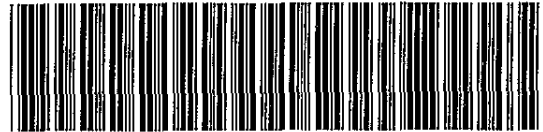

ARTICLES OF INCORPORATION

of

We, the undersigned, hereby declare the purpose of forming a corporation for profit under the laws of the State of Florida.
