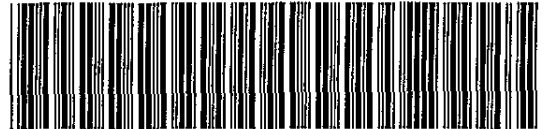



ARTICLES OF INCORPORATION OF ***Quality Floorscapes, Inc.***

ARTICLE I. NAME

The name of the corporation is:




