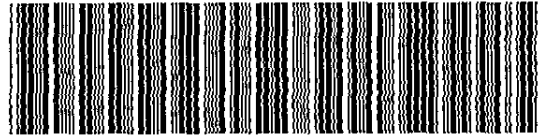

ARTICLES OF INCORPORATION
OF

ROBERTO GONZALEZ BLDG. CONTRACTOR, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is:

ROBERTO GONZALEZ BLDG. CONTRACTOR, INC.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. The general purpose for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in anyway.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

Article 4. Capital Stock. The aggregate number of shares which the Corporation is authorized to issue is 1,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

Article 5. Initial Registered and Principal Office. The street address of the initial Registered Agent and Principal Office of the Corporation is, **9101 SW 48th Street, Miami, Florida 33165**, and the name of its initial Registered Agent at this address is, **JULIA M. GONZALEZ**.

Article 6. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is one (1). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one (1). Article 7. Incorporators. The name and address of each Incorporator is as follows: **ROBERTO GONZALEZ, 9101 SW 48th Street, Miami, Florida 33165**.

Article 8. Amendment. The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.
