

# ARTICLES OF INCORPORATION

OF

#### A A & S DRYWALL, INC.



The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby associates himself to form a corporation for profit under the laws of the State of Florida.

## ARTICLE I-NAME

The name of the corporation is A A & S DRYWALL, INC.

## ARTICLE II - PURPOSE
