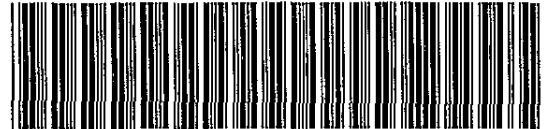


#### ARTICLE X – AMENDMENT


