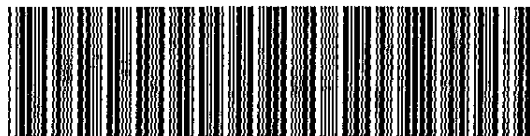



ARTICLES OF INCORPORATION

OF

T & P Painting, Inc.

ARTICLE I

Name

1.1. The name of the corporation is T & P Painting, Inc. and the corporation's business address is 7802 Andalucia Place, # A, Tampa, Florida 33614.

ARTICLE II

Duration

2.1 This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State of Florida.

ARTICLE III

Purpose

3.1 This corporation is organized for the purpose of an painting contracting business and transacting any and all lawful business.

ARTICLE IV

Capital Stock

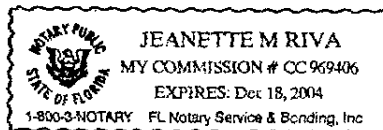


