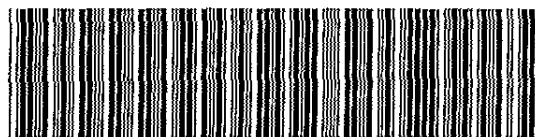

transacting any or all lawful business.


ARTICLE III


