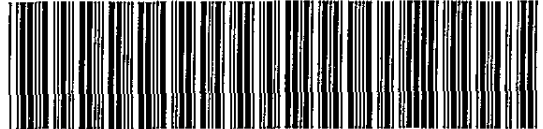

ARTICLE I

NAME

The name of this corporation shall be: MK Highland Enterprises, Inc.

ARTICLE II

TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE III

PURPOSE

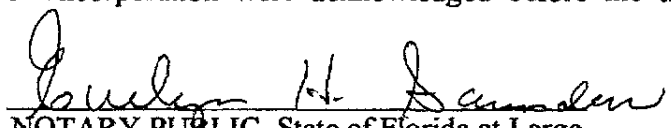

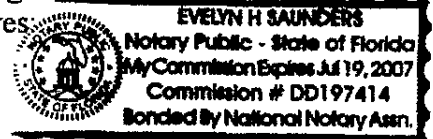
