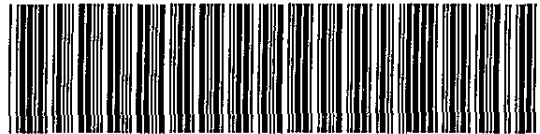



ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of this corporation is —

ARTICLE II. DURATION

This corporation shall commence January 1, 2004, and shall have perpetual existence. —

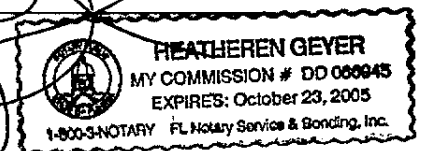
