

ARTICLES OF INCORPORATION OF JEREMY WORKMAN'S FLOOR COVERING, INC.

The undersigned incorporator, being one (1) in number, for the purpose of becoming a body corporation hereby adopt the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be JEREMY WORKMAN'S FLOOR COVERING, INC., hereinafter referred to as the "Corporation." In doing so, the official and physical address shall be at 123 State Street, Pensacola, Florida 32506.

ARTICLE II: DURATION

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Secretary of State.

ARTICLE III: PURPOSE

The Corporation is organized for the purpose of engaging in the business of construction that includes the buying and selling of construction materials, the subcontracting of subcontractors, the leasing and renting of equipment, and for the purpose of transacting any or all other lawful business not inconsistent with the Laws of the State of Florida.

ARTICLE IV: CAPITAL STOCK

The aggregate number of shares of stock said corporation is authorized to have outstanding at any one time shall be 10,000 shares of voting common stock at \$1.00 par value. In doing so, it is stipulated that the total authorized capital of this corporation shall be valued at ten thousand dollars (\$10,000.00) divided into 10,000 shares at \$1.00 par value per share, all of which may be outstanding at any time when appropriately and lawfully issued. Jeremy D. Workman, the majority shareholder has the right to purchase any and all shareholder's stock at the original issuance stock price at any given time without written notice. Furthermore, Jeremy D. Workman has the first right of refusal to purchase any and all stock held by all shareholders at original issuance stock price. For definition purposes, original stock price is valued at a \$1 Dollar per share.

ARTICLE VI: INITIAL REGISTERED OFFICE AND AGENT

The principal office and street address of the Corporation is: 123 State Street, Pensacola, Florida 32506.

The name of the registered agent of the corporation is: Jeremy D. Workman, and the street office address of such registered agent and registered office of the Corporation is: 123 State Street, Pensacola, Florida 32506.

ARTICLE VII: INITIAL BOARD OF DIRECTORS AND OFFICERS

The number of directors of said corporation is hereby fixed no more than five. The number of directors to be chosen for any year is determined by the stockholders at the annual meeting for the election of directors. In provision the number of members of the Board of Directors shall consist of two members until the first annual stockholders' meeting.

The officers and board of directors are subject to the provision of the Articles of Incorporation, the by-laws of this corporation, and the laws of the State of Florida. They shall hold office for the first year of service of the corporation until successors are elected. The following are the qualified and elected directors and officers of the corporation for the first year:

ARTICLE IX: AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law.
