ARTICLES OF INCORPORATION  
of

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I:** The name of this corporation is **Ron Harshman Services, Inc.**

**ARTICLE II:** This corporation shall exist for perpetuity commencing on the date of execution of these Articles.

**ARTICLE III:** This corporation is organized for any and all lawful business allowed under the laws of the State of Florida and/or the United States of America.

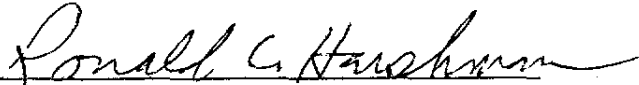
**ARTICLE VIII:** The name and address of the person signing these Articles is **RONALD C. HARSHMAN**, as Incorporator.
