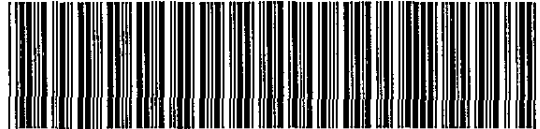

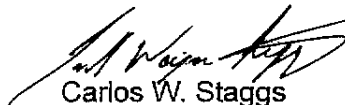

# ARTICLES OF INCORPORATION OF ***C. Wayne's Flooring, Inc.***

## ***ARTICLE I. NAME***

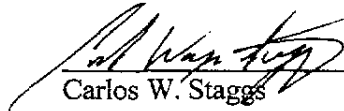

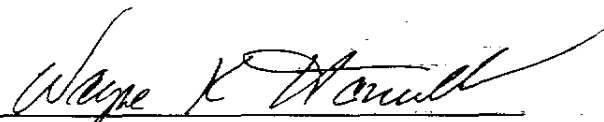

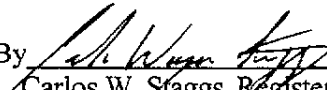
