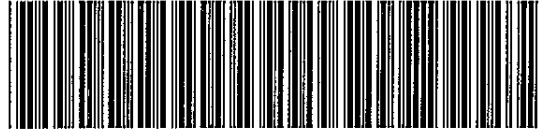

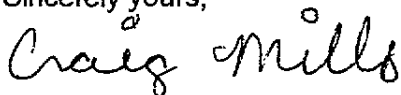

**ARTICLES OF INCORPORATION  
OF  
*Underground Flooring, Inc.***

***ARTICLE I. NAME***

The name of the corporation is:
