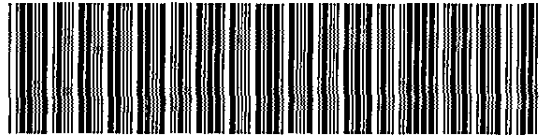

ARTICLES OF INCORPORATION
OF
SOUTHERN CLASSIC TREE FARM, INC.

The undersigned Incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the Corporation is Southern Classic Tree Farm, Inc.

ARTICLE TWO

PRINCIPAL OFFICE AND ADDRESS

The address of the principal office of the Corporation is 7643 McKeown Mill Road, Sneads, Florida 32460 and the mailing address of the Corporation is 7643 McKeown Mill Road, Sneads, Florida 32460.

ARTICLE THREE

SHARES, CLASS AND PAR VALUE

The Corporation is authorized to issue one class of shares, which shall be called common shares. Common shares shall have unlimited voting rights and shall be entitled to receive the net assets of the Corporation upon dissolution. The Corporation is authorized to issue 1,000 common shares, and shall have a par value of \$1.00 each.

Tullo-Williams. The registered agent, Gina M. Tullo-Williams, hereby accepts appointment as registered agent for the Corporation, Southern Classic Tree Farm, Inc.
