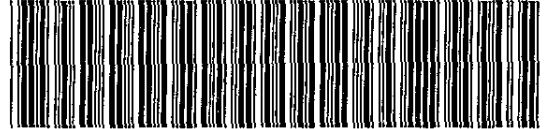

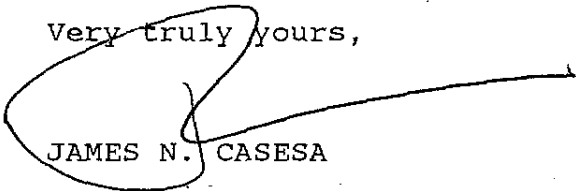

ARTICLES OF INCORPORATION

FOR

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is Hardwood Floors Speciality Contractors, Inc..

The duration of the corporation is perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are:

1. To install hardwood flooring.

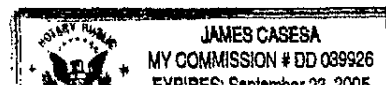
