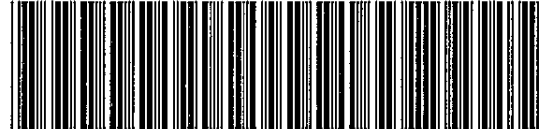

ARTICLES OF INCORPORATION

ARTICLE I - NAME EFFECTIVE DATE 12/4/03

The name of this corporation is Daniel P. McBride, P.A.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

This corporation is organized for the purpose of rendering specific professional service as chiropractors.

ARTICLE IV - CAPITAL STOCK
