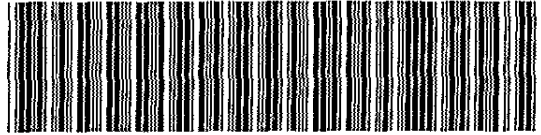

ARTICLES OF INCORPORATION

FOR

WILLIAM C. SHAW MAINTENANCE SERVICES, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is William C. Shaw Maintenance Services, Inc..

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are:

1. To engage in building maintenance and janitorial services.

2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.


